Arkansas Fair Managers Association Announces Innovative New Convention Format

The Arkansas Fair Managers Association (AFMA) is excited to announce a new and improved format for its upcoming annual convention, designed to serve as a comprehensive hub for fair managers, staff, and volunteers across the state. This year's convention will focus on providing essential certifications, licenses, and workshops to help fairs become more successful, safe, and efficient.

This new format aims to make it easier for fair professionals to obtain the necessary credentials to run a modern fair.

The new offers we are working to lock in at the convention will include, but not limited to:

- **NPIP Private Tester School**: This certification is crucial for individuals who need to perform blood tests on poultry for Pullorum-Typhoid disease, which is often a requirement for birds exhibited at fairs and shows.
- ServSafe Certification: A must-have for anyone handling food, the ServSafe certification ensures that fair vendors and staff are trained in proper food safety protocols, protecting both participants and the public.
- **Beef and Pork Quality Assurance (BQA/PQA)**: These programs educate producers and show exhibitors on best practices for animal care, welfare, and handling, ensuring a high-quality and safe food supply.

* EIA Coggins Verifier: Fair managers and staff will be able to get certified as Coggins verifiers, enabling them to check for required Equine Infectious Anemia (EIA) test results for all equine entering an event.

In addition to these important certifications, the AFMA convention will also host a session featuring fairs.com and the Fairs Across America Tour. This session will provide valuable information from barn to midway, main gate to grandstand, they capture the critical role Fairs play in bringing your communities together.

We are committed to providing the resources our members need to succeed. This new convention format is a direct response to the needs of our fairs. We want to be the central location where you all can get the necessary tools and learn new skills to help your fairs grow and thrive.

The AFMA convention is striving to be an invaluable event for fair organizers seeking to elevate their operations and ensure compliance with modern standards.
